#### 1 Introduction

This report presents data relating to the 2020 General Election, which may be helpful in mapping additional changes to Pennsylvania's Election Code prior to future elections. It includes some data not required by Act 35 of 2020, in order to provide helpful context for and a more complete presentation of the data.

The Department believes that the negotiations that led to the passage of Act 77 of 2019 and Act 12 of 2020 benefited all voters, and that future collaborations could do the same.

As the Department noted in the initial Act 35 of 2020 Report, and as it has repeated on multiple occasions since then, the single most important recommended change to the Election Code is the expansion of the pre-canvassing period. As we saw in the days following the 2020 General Election, even with staff working around the clock, counties were not able to finish canvassing their ballots until nearly a week after Election Day. This delay led to the dissemination of misinformation about the reliability and integrity of the election results.

An expansion of the pre-canvassing period would benefit all Pennsylvanians by facilitating more timely results and by helping to instill faith in the democratic system and the integrity of our elections. The counties overwhelmingly support this reform, and we hope the legislature shares this priority and will amend the Election Code to allow counties the flexibility to begin precanvassing their ballots well before the close of the polls during the May 2021 Primary Election and in future elections.

The data referenced and presented in this report were obtained from two sources: The Statewide Uniform Registry of Electors (SURE), which is the statewide database used by county election officials to maintain elections and voter data, and the responses to uniform surveys that the Department sent to each county board of elections. Each county board of elections is responsible for ensuring the accuracy of the data that it enters into SURE and for its own responses to the Department's surveys. The Department does not independently verify or guarantee the accuracy of the data provided by the county boards of elections.

#### 11 REVIEW OF ACTIONS TAKEN

To the extent consistent with Federal and State law, a review of any action taken by the Department of State, county board of elections or registration commission in response to an incident described below, including determinations made on the incident, legal actions filed and referrals to law enforcement.

The number of incidents known to the Department of State, county board of elections or registration commission relating to each of the following categories:

- (i) An absentee ballot or mail-in ballot which was sent to the wrong individual or wrong address.
- (ii) An absentee ballot or mail-in ballot which was voted by an individual other than the individual who applied for the absentee ballot or mail-in ballot.
- (iii) An absentee ballot or mail-in ballot which was returned to the county board of elections by a means other than the elector sending the absentee ballot or mail-in ballot by mail or delivery in person.

Counties collectively reported that approximately 500 ballots were sent to the wrong voter or to the wrong address. Of this total, approximately 200 were reported by Westmoreland County, 125 were reported by Lebanon County, and 105 were reported by Carbon County.

Westmoreland County reported that approximately 200 ballots were sent to the wrong address due to clerical errors.

Lebanon County reported that 125 ballots were sent to the wrong address due to an error during the transmission of voter data to the county's print and mail vendor. A manual correction to a file of absentee voters resulted in the name and address information for the voters in this file being mismatched, meaning that the ballots were sent to the correct voters but at the wrong addresses. The county immediately reissued ballots for these voters as soon as it became aware of the error and thus no ballots were improperly counted.

Carbon County reported that 105 voters applied for absentee and mail-in ballots and subsequently relocated due to the COVID-19 pandemic. Many of the ballot envelopes were returned to the county as undeliverable.

The causes of the remaining errors and irregularities include ballots that were delivered to the wrong address due to human error or ballots that were undeliverable because voters provided an invalid address.

Counties reported that 169 ballots were voted by someone other than the voter. Of this total, Philadelphia reported that 125 ballots were filled out and signed by someone other than the voter to whom the ballot was addressed. Based on the information provided by the county, the county concluded that these ballots were likely delivered to the wrong individual or were completed by a spouse or other family member. Philadelphia County did not count any of those

125 ballots. Dauphin County reported that 8 ballots were voted by someone other than the voter for reasons including family members voting the ballot of another family member, multiple voters at the same address, or the ballot was delivered to the wrong street address. In each case, the ballots were not counted and in one case the county was able to void the erroneously voted ballot and replace it. The remaining cases include isolated incidents where another family member or another voter at the same address inadvertently voted the wrong ballot. In each case, the erroneously voted ballots were not counted by the counties.

Based on the information reported by the counties, the overwhelming majority of these situations did not appear to be willful nor attempted fraud, and thus they were dealt with administratively.

Three alleged cases of fraudulent voting were reported in three separate counties:

- Delaware County reported one case of a fraudulent vote cast by an individual for a deceased relative. The individual in question submitted an application on behalf of the deceased relative. During the process of verifying the ID on the application, the SURE system flagged the applicant as deceased. Subsequently, the county followed up with the applicant and the individual who submitted the application signed a letter asserting that the deceased relative was still alive. Prior to the 2021 Municipal Primary the department updated the SURE system by deploying a "hard stop" that requires rejection of the application when information on a voter's application indicates that the applicant may be deceased. The county will only be able to reprocess the application upon receiving evidence from the applicant that she is qualified.
- The two additional cases of alleged fraud one in Chester County and one in Luzerne County currently have criminal cases pending.

Counties reported that a total of 976 ballots or emergency absentee ballots were returned by means other than the voter sending it by mail or delivering it in person to a site designated by the county board of elections. In all 976 cases, the ballots were delivered on behalf of the voters by their duly designated agents as permitted by the Election Code.

In addition to the issues summarized in the preceding paragraphs, Allegheny County and Blair County reported issues they encountered prior to the November 2020 General Election with ballots printed and delivered by their respective print and mail vendors.

Allegheny County reported that 28,879 ballots were sent to voters several weeks before the November 2020 General Election with the wrong ballot style enclosed (incorrect municipality, ward or precinct) due to an image mapping error by the county's print and mail vendor. Allegheny County issued corrected ballots to all 28,879 voters with unique ballot return envelopes and segregated any incorrect ballots that were returned by the affected voters to ensure that the incorrect ballots could be voided. In addition, the county established an online search tool that voters could use to determine if they were one of the affected voters.

Blair County reported that 78 voters who requested mail-in ballots in Logan 2 received two ballot packages. The print and mail vendor advised the County that during the run of the initial batch of 387 mail-in ballots for Logan 2, a printer stopped working at 309 ballots, and the remainder of the print job starting at ballot 310 was completed on another printer. The next day, the printer that stopped mid-batch completed the interrupted print job and the remaining 78 ballot packages were processed. Subsequently, the vendor added a second cross-check on addressed ballot packages to ensure that this error does not occur again.

#### 12 Issues or Incidents Involving Voting Machines

A review of issues or incidents encountered with an electronic voting system that received the approval of the Secretary of the Commonwealth under section 1105-A of the Pennsylvania Election Code, including any technical issues encountered in polling places.

Counties reported relatively few voting system errors or issues in the 2020 General Election. Of the 13 counties that reported voting system issues, all but four (4) counties reported only isolated issues with scanners or ballot-marking devices that were quickly resolved through maintenance or replacement.

#### For example:

- 1. Adams County reported a "tension issue" with its DS450 central tabulator that resulted in two ballots being pulled through the scanner at one time. This issue was resolved immediately with an adjustment to the scanner and the county was able to resume scanning ballots.
- 2. Armstrong County indicated that a total of 45 ballots could not be read by the central scanner and had to be tabulated manually.
- **3.** Butler County reported that one DS850 central tabulator broke down. They were able to quickly replace it.
- **4.** Clinton County reported that one precinct scanner malfunctioned. The scanner was replaced within 20 minutes.
- 5. Luzerne County reported startup errors due to human error in several of their polling places. They were able to resolve these errors with poll workers over the phone.
- 6. Lancaster County reported several printer connection issues at polling places due to human error. They were able to resolve these issues with poll workers over the phone.
- 7. McKean County reported ballot jamming issues with some precinct scanners, requiring that their precinct election officials periodically release ballot jams manually.
- 8. Philadelphia County reported various routine issues, such as screen calibration issues, screen freezes, and ballot jams. Each of these issues were either resolved over the phone or by technical support staff dispatched to the polling places. The county also received calls from 35-40 divisions who needed assistance over the phone or from technical support staff during the process of opening the polls
- 9. Snyder County reported that one precinct had difficulty closing the polls due to human error. This issue was resolved quickly with the assistance of technical support staff who were dispatched to the polling place.

In addition to these isolated issues, the following four counties reported issues or errors that were more widespread, or needed additional troubleshooting beyond what is typical:

1. Bucks County reported that systematic issues adjudicating mail ballots during scanning, so they had to be adjudicated manually. The county determined that the cause of the issue was human error during the creation of ballot proofs. One of the ballot proofs provided to the county's print vendor was incomplete, containing incorrect timing marks.

The County and the Department are working together to ensure that pre-election testing is robust enough to identify and correct this type of human error.

- 2. Butler County reported two issues during the reconciliation of vote totals, and the following determinations have been reported:
  - a. The county found a 481 vote discrepancy in its Election Management System (EMS) from a USB media with 481 ballots. It was determined that a user responded improperly to a system message. The user was prompted with a query on the election management software asking whether the results from a previously tabulated USB media should be removed during the process of preparing another USB media to tabulate ballots. The user agreed to the prompt, which removed the vote totals from the previously tabulated media. This became apparent later when there were fewer total votes. Despite this issue, the county was able to confirm the accurate numbers for the certification through reconciliation of vote totals. The Department will ask the voting system vendor Election Systems & Software ("ES&S") to make system prompts clearer to prevent similar issues in the future.
  - b. Some provisional ballot vote totals were not properly uploaded to the EMS. When the county attempted to upload these totals, which were contained on a single USB media, the county user didn't realize that the EMS server was switched off. As a result, the county began receiving error messages indicating that the election database could not be found. Despite these issues, the county was able to confirm the accurate numbers for the certification through reconciliation of vote totals. Butler is the only county that reported this experience.
- 3. Northumberland and McKean counties reported that they experienced ballot jams at most of their precincts at the 2020 General Election. The counties and the Department worked with ES&S to identify the root cause of the issue. ES&S concluded that depending on the conditions of polling place setup, static and suction can interfere with the free fall of ExpressVote ballot cards into the ballot box attached to the ExpressVote precinct scanner. To mitigate the issue ES&S will install a conductive gasket onto the exit guide of the ExpressVote scanner to prevent static and suction. ES&S submitted an Engineering Change Order (ECO) to the Election Assistance Commission (EAC) and the change was successfully tested by a federal voting system testing authority. Because this change is de minimis and it does not impact the accuracy or integrity of the voting system, no additional federal or state testing is necessary. The ECO was approved by the EAC on February 19, 2021, and the gaskets are being installed in Pennsylvania counties prior to the May 2021 Municipal Primary.
- 4. Clinton There was one precinct scanner that had to be replaced on election day.

- 5. Adams County The DS450 was sucking in 2 ballots on each pull. ES&S immediately sent tech support and it was fixed. The county had only one DS 450 and it was resolved within an hour. The device was moved on the elevator and the vibrations might have caused the tension to be different from when it was calibrated.
- 6. Bucks County Manually adjudicated all absentee ballots. County staff sent a ballot definition file for absentee and mail ballots to the print vendor and the vendor began printing ballots. Subsequent to delivering the file to the print vendor, the county had to make a correction to the mail-in ballot definition files. Upon making those corrections, the timing marks on ballots printed after the change were different than those on ballots printed before the change. As a result, when the ballots were scanned on Election Day the system was not able to tabulate the ballots and staff had to manually assign votes. There were about 25,000 absentee/mail ballots that required manual adjudication. Both political parties were aware of the issue and were permitted to observe as the ballots were adjudicated. The county conducted a random check/audit of the adjudicated ballots with the parties present and able to observe.

#### 13 CONCLUSIONS

Despite the challenges presented by COVID-19 and delayed mail service, Pennsylvanians registered and voted in record numbers in the 2020 General Election. Approximately 9.1 million Pennsylvanians are registered to vote, 300,000 more voters than have ever previously been registered. And turnout in the November General Election included more than 6.9 million voters - 800,000 more Pennsylvanians than voted in any prior election in our history. The November 3, 2020 General Election was safe, secure, transparent, and accessible.

The Department continues to support counties beginning the pre-canvassing process as early as three weeks before Election Day. The original Act 35 Report referenced the Democratic Primary for Auditor General as an example of why this change needs to be made. While one candidate led on the night of the primary, due to delays in canvassing of ballots, it was not until days later that a different candidate took the lead as ballots continued to be counted. The complete scope of this issue was on full display for the entire nation in the days following November 3 when this same situation played out on a much larger and more public scale. The Department agrees with the County Commissioner's Association and others who have urged that a legislative change be made as soon as possible to allow pre-canvassing to begin earlier.

Election officials at the state and local levels, Republican and Democrat alike, worked tirelessly amid a pandemic so that voters could safely and securely decide this election. Counties administered the election with the highest degree of transparency, several with a 24/7 livestream of the ballot-counting process available for anyone to watch, in addition to the bipartisan teams of election officials, party officials, and other observers of the process.

The most significant change necessary to ensure even greater efficiency of our election administration is that the counties be permitted to pre-canvass mail-in and absentee ballots ahead of Election Day, like the 46 other states that permit the same.

The Department of State and the counties will continue to work together for our democracy, to ensure that the vote of every qualified voter is counted securely and accurately.
